



## PROCEDURE FOR MEDIA ACCREDITATION BEFORE THE PERUVIAN INSTITUTE OF MINING ENGINEERS - IIMP

## CONDITIONS FOR ACCREDITATION

All journalists who submit a request for accreditation to the Peruvian Institute of Mining Engineers (IIMP) as organizer of the event "13th INTERNATIONAL CONGRESS OF PROSPECTORS AND EXPLORERS - PROEXPLO 2023", must submit truthful information to validate its authenticity and validity, such as:

- A press card issued by the media (print, digital, radio or television; specialized or mass media relevant to the industry, the event and of national interest) where he/she works.
- A letter on official letterhead of the corresponding news media.
- Company name of the media (print, digital, radio or television) indicating that it is a registered media company currently active.
- RUC taxpayer identification number of the media (print, digital, radio or television) in active status.
- In the case of <u>print</u> media:
  - The publication must have a minimum of four (4) editions of authorship (in the period 2022-2023).
- In the case of <u>television</u> media:
  - It must have continuous transmissions during the last 6 months prior to the application for accreditation (year 2023).
- In the case of <u>radio</u> media:
  - $\circ~$  It must have continuous transmissions during the last 6 months prior to the application for accreditation (year 2023).
- In the case of media published on the Internet (<u>digital</u> media), the following conditions must be met:
  - The online publication must have been continuous during the last 6 months preceding the application for accreditation (year 2023).
  - Also, it must belong to a company registered as a media, with a verifiable address outside the web, that is to say, it must have a verifiable postal address and a telephone number.
  - The online publication must disseminate a significant amount of original information, commentary or analysis on national or international issues.
  - $\circ$   $\;$  Social media profiles will not be considered as digital media.

## CLARIFICATIONS

Accreditation will only be granted to journalists who submit the required documentation and validate that they work for and/or represent a registered media.

Journalists may be required to submit: the last two (02) issues of their publication, if they represent a print media; the recordings of two (02) recent news stories, if they represent a radio station or television channel; one (01) letter from the audiovisual media outlet intending to broadcast their work, if they work for independent television production companies; original





press clippings and photos with the name of the publication that edited them, if they are graphic reporters; or three (03) recent articles signed with their name, if they work for information media published on the Internet.

The Peruvian Institute of Mining Engineers - IIMP may request additional documented evidence to clearly establish the conditions of applicants and validate their authenticity. Applications will be considered on a case-by-case basis and the IIMP's decisions are final.

The Peruvian Institute of Mining Engineers (IIMP) reserves the right to deny or cancel the accreditation to journalists of the media if they do not present truthful information and whose activities are contrary to the activities of the event "13th INTERNATIONAL CONGRESS OF PROSPECTORS AND EXPLORERS - PROEXPLO 2023".

Journalists applying for accreditation must submit their information starting Wednesday, March 15, 2023 and no later than Friday, April 28, 2023.
