



# RULES FOR ACCREDITATION AND STAY OF JOURNALISTS AT THE VENUE OF THE 13TH INTERNATIONAL CONGRESS OF PROSPECTORS AND EXPLORERS PROEXPLO 2023

#### **GENERAL**

**Article 1°** - These rules are mandatory for journalists attending the 13th International Congress of Prospectors and Explorers - PROEXPLO 2023 to be held from May 8 to 10, 2023 at the Lima Convention Center.

**Article 2° -** Rules and regulations are intended to determine the conditions for the registration and development of journalists' activities within the framework of PROEXPLO 2023.

**Article 3°** - Journalists must coordinate only with the Communications area of the Peruvian Institute of Mining Engineers (IIMP), which will be in charge of providing guidance, information and coordination within the framework of PROEXPLO 2023.

## PRESS ACCREDITATION PROCESS

**Article 4°** - Journalists shall register online by filling out the Press Accreditation Form, in which they shall indicate their contact and media information.

**Article 5°** - The Press Accreditation Form shall be sent no later than April 28, 2023. After this date, no new applications will be accepted either by e-mail or in person at the IIMP and/or the event.

**Article 6°** - Accredited journalists will receive a confirmation by e-mail only through <a href="mailto:prensa@iimp.org.pe">prensa@iimp.org.pe</a> up to 5 working days after sending their contact and media information. The IIMP reserves the right to approve or deny accreditation applications submitted within the indicated deadline.

**Article 7°** - Accredited journalists have access to the program activities and to the exhibition, subject to availability and capacity of the event.

**Article 8°** - A maximum of 2 badges shall be granted for each media outlet in the case of print, radio or digital press and 3 badges in the case of television media.

## **BADGES**

Article 9° - Accredited journalists may pick up their badges at:

- Venue: PROEXPLO 2023 registration module located at the Lima Convention Center.
- Date and Time: Saturday 6<sup>th</sup> and Sunday 7<sup>th</sup>, from 9:00 a. m. to 1:00 p. m. and from Monday 8<sup>th</sup> to Wednesday 10<sup>th</sup>, from 8:00 a. m. to 6:00 p. m.

If you have not picked up your badges by the stipulated dates and times, please come to the event venue with your confirmation email and ID to pick up your badge. There will be no on-site registration during the dates of the event.

**Article 10°** - All accredited journalists must carry their badges at all times in a visible manner. These badges are mandatory, personal and non-transferable. This document will be the only authorization to enter the conference rooms and exhibition fair.

Article 11° - In case of loss of the badge, replacement will have a cost of USD 50.00.

#### **COVERAGE AND TRANSMISSIONS**

**Article 12° -** Journalists who need to install equipment for live or delayed transmissions should notify in advance by e-mail to <a href="mailto:prensa@iimp.org.pe">prensa@iimp.org.pe</a> to make the respective arrangements.

**Article 13°** - Press room, conference rooms, among other activities, shall be accessed within the spaces designated for journalists, maintaining order, and respecting the capacity of each of the aforementioned rooms.

## HANDING OUT AND/OR DISPLAY OF ADVERTISING MATERIALS

**Article 14°** - The distribution and/or exhibition of unauthorized advertising material is prohibited at the entrances to the venue, areas adjacent to administrative offices, conference rooms of the event, restaurant, and exhibition areas.

## **ACCESS AND PERMANENCE CONTROL**

**Article 15°** - Journalists will always have the support and assistance of the Communications area of the Peruvian Institute of Mining Engineers (IIMP) during the days of the event.

**Article 16°** - If an invalid badge is identified and/or does not correspond to the journalist, it will be confiscated and entry to the event venue will be immediately prohibited.

**Article 17°** - Journalists who fail to comply with the articles established in the rules and regulations, as well as with the standards of conduct, will receive a warning from the event organizers. If they persist in this attitude, they will be removed by security agents, withholding their badges and preventing them from re-entering the event venue.

### RESPONSIBILITIES OF THE PERUVIAN INSTITUTE OF MINING ENGINEERS

**Article 18°** - The Peruvian Institute of Mining Engineers (IIMP) shall not be liable for non-compliance due to unforeseeable circumstances or force majeure. For these purposes, unforeseeable circumstances or force majeure is understood as a non-imputable cause consisting of an extraordinary, unforeseeable and unavoidable event that prevents the performance of services or that causes their partial, late or defective performance.

Such events include fires, earthquakes, tsunamis, landslides, avalanches, floods, torrential rains, storms, explosions, military conflicts or external or internal wars, civil commotions, blockades, acts of terrorism and sabotage, uncontrollable delays in transportation, strikes and work stoppages, as well as any other similar or different cause, understanding that this list is merely enunciative and not exhaustive, and therefore all events beyond the reasonable control of the parties and which could not have been foreseen or could not have been avoided, and for the loss or damage caused to equipment, tools and materials, are included.
